PUBLIC HEARING: PLAT AND REZONE TO AG-B2 COWAN TRACT 2 IN SE ¼ **SECTION 18 112-80:** Time set for 5:30 PM to consider a request from Paul & Loretta Cowan Family Land Limited Partnership to plat Cowan Tract 2, a subdivision of the S1/2 SE1/4 of Section 18 112-80 and rezone to Ag-B2. Paul and Loretta are proposing that Cowan Tract 2 be a residential lot with approximately 10 acres for their granddaughter and her husband to build a home. Nobody appeared to testify. Moved by Abernathy and seconded by Brown to approve Resolution No. 2024-12 the Plat of Cown Tact 2 in SE ¼ Section 18 112-80 and Ordinance No. 2024-03 Rezone Cowan Tract 2 SE ¼ Section 18 112-80 to Ag B2. All voted Aye. Motion passed.

PUBLIC HEARING: PLAT AND REZONE TO AG-B2 LOVELL TRACT 2 IN SE ½ **SECTION 13 112-80:** Time set for 5:35 PM to consider a request from Michelle Metzinger to plat Lovell Tract 2 a subdivision of the SE 1/4 SE 1/4 of Section 13 112-80 and rezone to Ag-B2. Lovell Tract 2 is a proposed residential lot that will be approximately 10 acres. The house on the proposed parcel was home to Michelle Metzinger's grandparents and is currently unoccupied. Lovell Tract 2 would create a 10-acre parcel that includes the home and outbuildings. This plat would allow the home to be sold and occupied while allowing Metzinger to retain ownership in the remaining 150 acres of the SE quarter. Michelle Metzinger was available for questions. Moved by Brown and seconded by Abernathy to approve Resolution No. 2024-13 the Plat of Lovell Tract 2 in SE ½ Section 13 112-80 and Ordinance No. 2027-04 Rezone Lovell Tract 2 SE ¼ Section 13 112-80 to Ag B2. All voted Aye. Motion passed.

FINAL CONSIDERATION: PLAT OF LOT 1 DONAHUE ADDITION IN NE ¼ SECTION 6 109-75: Kay Donahue is proposing a plat of Lot 1 Donahue Addition NE ¼ Section 6 109-75. Kay owns the portion of the NE1/4 of Section 6 109-75 that is north of SD Highway 34, approximately 102.79 acres. She is requesting to plat off the home and outbuildings from the remainder of the parcel. The proposed plat is approximately 35.25 acres and will comply with Ag-B zoning restrictions, no zoning change is needed to approve and file this plat. Her plans following plat approval include relocating and converting the existing home into a barn or shed in a different location on the parcel and placing a new home in the location of her current house. Kay Donahue appeared for questions. Moved by Brown and seconded by Fines to approve Resolution No. 2024-14 the Plat of Donahue Addition in NE ¼ Section 6 103-75. All voted Aye. Motion passed.

FINAL CONSIDERATION: PLAT OF LOTS 1 & 2 HELEN'S PLACE SUBDIVISION OF W ½ NE NE SECTION 30 112-80: Rita Koch is requesting a proposed plat of lots 1 & 2 Helen's Place a subdivision of the W ½ NE ¼ NE ¼ Section 30 112-80 with no change to the current Ag-B2 zoning. Rita owns the parcel and the house. The parcel apparently pre-dates Hughes County Planning & Zoning ordinance as it is too small to comply as a legally described parcel instead of a platted parcel. The house is a Governor's home that was placed there around 2001 by John & Helen Tuveson, Rita's parents. The proposal is to split the approximately 19-acre parcel into 2 parcels. Lot 1 will be approximately 9.332 acres with Lot 2 being approximately 9.868 acres. Lot 2 will be sold to the Petersons who own the adjacent parcel to the west. The home and accessory structure are on Lot 1, the buildings will comply with setbacks following the subdivision. Approaches along 200th St in this stretch are no longer available because the current number exceeds what is allowed by ordinance. Staff has agreed to allow easement access to Lot 2 via an existing approach that accesses the entire parcel. Staff has agreed to this because the Petersons have stated they intend to plat Lot 2 with their Lot 3R of Venner's Peoria Heights Addition as soon as their current mortgage is satisfied. Jay Peterson appeared for questions. Moved by Abernathy and seconded by Fines to approve Resolution No. 2024-15 the Plat of Lots 1 & 2 Helen's Place a subdivision of W ½ NE NE Section 30 112-80. All voted Aye. Motion passed.

2024 PRIMARY POST-ELECTION AUDIT: Finance Officer Thomas J. Oliva informed the Commission of the results of the first ever Post-Election Audit conducted on June 12, 2024 at the Hughes County Courthouse.
