RESOLUTION NO. 2025-05 BRIDGE REINSPECTION PROGRAM RESOLUTION FOR USE WITH SDDOT RETAINER CONTRACTS

<u>WHEREAS</u>, 23 CFR 650 Subpart C, requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

THEREFORE, Hughes County is desirous of participating in the Bridge Inspection Program.

The County requests SDDOT to hire Brosz Engineering, Inc. (Consulting Engineers) for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection services rendered, and bill the County for 20% of the cost. Moved by Abernathy and seconded by Hohn to approve the correction to the Sheriff's Office overtime schedule listed in the December 2, 2024 meeting minutes. Sheriff Deputies will receive overtime for all

hours physically worked over 40 in a one-week period effective December 2, 2024. All voted Aye. Motion passed.

Commissioner Hohn stated that the Shift Differential Pay was not included in the Hughes County employee handbook and the additional pay should not be granted. Moving forward be it known that the Hughes County employee handbook supersedes previous motions that may contradict the handbook.
